**DUTIES:** Provides overall supervision over the office of the Attorney General. Responsible for the preparation of opinions on questions of laws for the various ministries and government agencies. Responsible for the review of legislative acts, bills and laws, and works closely with the Minister, Cabinet, the President, and other officials on proposed for previously submitted bills to determine legal adequacy. Represents the office of the Attorney General in legal proceedings involving litigation within the Republic. Drafts motions, pleadings, answers, complaints, and other legal documents common to litigation and appears on behalf of the RMI Government in related litigation matters, procures evidence for prosecution, examines, and cross-examines witnesses or otherwise prosecutes suits in proceedings before the High Court of the Republic. Responsible for the enforcement of the Constitution of the Republic of the Marshall Islands. Responsible for the prosecution of all criminal court cases, and representing the Government in civil cases. Acts as the Registrar of Corporations. Performs other related duties as assigned.

**QUALIFICATION REQUIREMENTS.** Graduated from an accredited university of law plus at least five (5) years of experience in the field of general law, including experience in an administrative capacity. OR any combination of education and experience which may be acceptable to the Public Service Commission.
